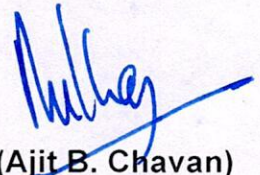
6. Travel and accommodation for one representative of your organisation shall be borne by GeM, as per the entitlements and terms set out in the Annexure enclosed with this letter.

ANNEXURE

Travel, Accommodation and Reimbursement

- GeM shall bear travel and accommodation expenses for maximum of 1 representative of the seller organization, subject to the limits given below.
- Train/Air travel: Economy class airfare by the shortest and most economical route, for sellers travelling from outside the Delhi/NCR region.
- Accommodation: Reimbursement up to ₹5,000 (Plus applicable Taxes) per night, for 1 night, covering the night of 9th and 10th August 2026.
- Local travel: Sellers based within the Delhi/NCR region shall be reimbursed actual local travel costs, subject to production of valid receipts.
- All claims are on a reimbursement basis against original tickets, boarding passes, hotel invoices (GST invoice, where applicable) and receipts. Claims must reach designated official of GeM within 10 days of the event on marketing-gem@gem.gov.in
- Reimbursement will be made by electronic transfer to the bank account of the seller organization. Cancellation charges, date-change fees, no-show charges and fare upgrades shall not be reimbursed.
- Expenses not expressly covered — including meals, in-room charges, laundry, incidentals, visa fees and extended stay — shall be borne by the seller.
- Where the representative is accompanied by an assistant or any additional person, all associated travel, accommodation and incidental expenses shall be borne entirely by the seller organization.
- Ticket and hotel bookings shall be made by the seller.
